**TYPE OF THE PUBLIC PROCUREMENT PROCEDURE:** A procurement procedure to which the Public Procurements Act shall not be applied.

**SUBJECT OF THE PUBLIC PROCUREMENT:** Goods

**DESCRIPTION OF THE SUBJECT OF THE PUBLIC PROCUREMENT:** Philatelic stamp mounts, no. N: 73/2017.

**NAME AND MARK FROM THE GENERAL PROCUREMENT DICTIONARY:** Trade advertising material, commercial catalogues and manuals – 22460000-2.

**CRITERIA FOR AWARDING THE AGREEMENT:** “the lowest offered price”.

**DATE OF PUBLICATION OF THE CALL FOR THE SUBMISSION OF BIDS:** 14.08.2017.

**DATE OF PUBLICATION OF THE EXTENSION OF DEADLINE FOR THE SUBMISSION OF BIDS:** 24.08.2017.

**REASON FOR THE EXTENSION OF DEADLINE:** Ensuring broader competition for bidders for the subject procurement and providing potential bidders with the conditions for clearer preparation of bids.

**THE MANNER OF SUBMITTING BIDS AND THE DEADLINE:** The Bids shall be prepared and submitted according to the Call of the Ordering party and the Bidding Documentation for the procurement in question. The Bidder shall submit the bid directly or by mail, in a sealed envelope or box, stamp-certified, to the Ordering party's address: PE Post of Serbia, Takovska 2, 11120 Belgrade, PAC 135403, Administration Office (hereinafter referred to as: Ordering party's address), **latest by Monday, 25.09.2017. 09.00 hrs**, marked with: **“BID FOR THE PUBLIC PROCUREMENT OF PHILATELIC STAMP MOUNTS, Procurement No. N: 73/2017 - DO NOT OPEN BEFORE THE MEETING FOR PUBLIC OPENING OF BIDS”**. Name and address of the Bidder shall be indicated on the back of the envelope or box. The Bid must be sealed in such a way that when the bid is opened it can be

determined with certainty that it has been opened for the first time. The bids received by the Ordering party within the deadlines set in the Call for bids shall be considered as timely submitted.

Within the deadline set for the submission of bids, the Bidder may amend, supplement, or revoke their bid. The Bidder shall submit **amendments, supplements, or revocation of the bid**, according to the manner determined for the submission of bid, to the Ordering party's address, and **with the note: "AMENDMENT/ SUPPLEMENT/ REVOCATION OF THE BID FOR THE PUBLIC PROCUREMENT OF PHILATELIC STAMP MOUNTS, IN THE OPEN PROCEDURE, PP No: N: 73/2017 – DO NOT OPEN BEFORE THE MEETING FOR PUBLIC OPENING OF BIDS"**.

**PLACE, TIME AND MANNER OF OPENING OF BIDS:** The Bids shall be opened publicly, on Monday, 25.09.2017 at 09:30 hrs, at the address of the Ordering party: Belgrade, Takovska Street No.2, Office no. 11.
