PLACE, TIME AND MANNER OF OPENING OF BIDS: The Bids shall be opened publicly, in the order of arrival, on the last day of the set deadline for submission of bids, i.e. on Things Day; Author 1, 2017 at 12: 50 hrs, at the Procuring party's address: Belgrade, TAXOV SA, No. 2, office No. 11 at the FANNO floor.

CONDITIONS UNDER WHICH THE REPRESENTATIVES OF THE BIDDERS MAY PARTICIPATE IN THE BID OPENING PROCEDURE: Only authorised representatives of the bidders may take an active part in the bid opening procedure.

Representatives of the Bidder, except for the Company Director, who will attend the public opening of the bids, have to submit a proxy, issued by the Company Director for participation in the public opening of bids, with an unambiguous note that the proxy refers to the subject procurement.

DEADLINE FOR MAKING THE DECISION: Deadline for making the decision on the agreement awarding is 25 days upon the day of opening the bids.
