REASON FOR THE EXTENSION OF DEADLINE: Ensuring broader competition for bidders for the subject procurement and providing potential bidders with the conditions for clearer preparation of bids.

THE MANNER OF SUBMITTING BIDS AND THE DEADLINE: The Bids shall be prepared and submitted according to the Call of the Ordering party and the Bidding Documentation for the procurement in question. The Bidder shall submit the bid directly or by mail, in a sealed envelope or box, stamp-certified, to the Ordering party's address: PE Post of Serbia, Takovska 2, 11120 Belgrade, PAC 135403, Administration Office (hereinafter referred to as: Ordering party's address), **latest by Monday, 25.09.2017. 10.30 hrs**, marked with: **“BID FOR THE PUBLIC PROCUREMENT OF PHILATELIC PLASTIC POCKETS, ENVELOPE PROTECTORS AND MAXIMUM CARDS, PHILATELIC TAPES, Procurement No. N-85/2017 - DO NOT OPEN BEFORE THE MEETING FOR PUBLIC OPENING OF BIDS”**. Name and address of the Bidder shall be indicated on the back of the

envelope or box. The Bid must be sealed in such a way that when the bid is opened it can be determined with certainty that it has been opened for the first time. The bids received by the Ordering party within the deadlines set in the Call for bids shall be considered as timely submitted.

Within the deadline set for the submission of bids, the Bidder may amend, supplement, or revoke their bid. The Bidder shall submit **amendments, supplements, or revocation of the bid**, according to the manner determined for the submission of bid, to the Ordering party's address, and **with the note: "AMENDMENT/ SUPPLEMENT/ REVOCATION OF THE BID FOR THE PUBLIC PROCUREMENT OF PHILATELIC PLASTIC POCKETS, ENVELOPE PROTECTORS AND MAXIMUM CARDS, PHILATELIC TAPES, Procurement No. N-85/2017 – DO NOT OPEN BEFORE THE MEETING FOR PUBLIC OPENING OF BIDS"**.
