DESCRIPTION OF THE PROCUREMENT SUBJECT: Supply of electric power, Public Procurement No:123/2019.

NAME AND MARK FROM THE GENERAL PROCUREMENT DICTIONARY: Electric power - 09310000-5.

CRITERIA FOR AWARDING THE AGREEMENT: "the lowest offered price".

THE WAY OF OBTAINING THE BIDDING DOCUMENTATION: The Bidding Documentation for the subject Public Procurement can be downloaded and is available on the Public Procurement Portal <a href="https://www.ujn.gov.rs">www.ujn.gov.rs</a> and the Procuring party webpage: <a href="https://www.posta.rs">www.posta.rs</a>.

THE MANNER OF SUBMITTING THE BIDS AND THE DEADLINE: The Bids shall be prepared and submitted according to the Call for submission of bids of the Procuring party and this Bidding Documentation. The biddser may submit only one bid. The Bids may be submitted in the sealed envelope or box, stamp-certified, in person or by post to the Procuring party's address: PE Post of Serbia, Takovska 2, 11120 Belgrade, PAK 135403, Registry office (hereinafter referred to as: the Procuring party's address), within twenty-five (25) days from the day of publishing the Call for submission of bids on the Public Procurement Portal, until WOWD + 7 22.07, 2019, at 2 50 hrs, at the latest. Also, a note should be inserted: "BID FOR PUBLIC PROCUREMENT OF ELECTRIC POWER SUPPLY, Procurement No.123/2019, - DO NOT OPEN BEFORE THE MEETING FOR PUBLIC OPENING OF BIDS". Name and address of the bidder shall be indicated on the back of the envelope or box. The Bid must be sealed in such a way that when the bid is opened it may be determined with certainty that it was opened for the first time. Timely submitted shall be the bids prepared by the Procuring party within the time determined in the Call for submitting of bids. The bids received by the Procuring party within the deadlines set in the Call for bids shall be considered as timely submitted.

The bidder may submit only one bid.

The bidder who independently submitted the bid cannot simultaneously participate in the joint bid, or as a subcontractor, and the same entity cannot participate in several joint bids.

Within the deadlines set for submission of bids, the Bidder may amend, supplement or revoke its bid. The bidder shall submit amendment, supplement or revocation of the bid, according to the manner determined for the submission of the bid, to the Procuring party's address, with the indication: "AMENDMENT/ SUPPLEMENT/ REVOCATION OF THE BID FOR THE PROCUREMENT OF ELECTRIC POWER SUPPLY, Procurement No. 123/2019 – DO NOT OPEN BEFORE THE MEETING FOR PUBLIC OPENING OF BIDS".

PLACE, TIME AND MANNER OF OPENING OF BIDS: The Bids shall be opened publicly, on 40wday; 22-0x 2019\_at \(\frac{1}{20}\):00 hrs, at the address: Belgrade, \(\frac{1}{20}\) TAWOV SWA \(\frac{2}{20}\), office No. \(\frac{1}{20}\).

CONDITIONS UNDER WHICH THE REPRESENTATIVES OF THE BIDDERS MAY PARTICIPATE IN THE BID OPENING PROCEDURE.

Only the authorised representatives of the bidders may take an active part in the bid opening procedure.

If the interested person for attending the public opening of bids and the representative of the Bidder, is a foreign citizen, he shall be obliged to submit a proxy, or written application for entering the official premises at the Procuring party's address in which the bids shall be opened publically, with the indicated date and hour when to attend the public opening of bids.

The bidder shall, in order to participate in the subject Public Procurement procedure, prove that he/she fulfills the mandatory conditions prescribed by the Article 75, Paragraph 1 of the Public Procurement Act ("The Official Gazette of the RS" No. 124/2012, 14/2015 and 68/2015, hereinafter referred to as the Act), as well as the additional requirements, pursuant to Article 76 of the Act stated in the Bidding Documentation for the particular Public Procurement.

**DEADLINE FOR MAKING DECISION**: Deadline for making the decision on the agreement awarding is 25 days upon the day of opening the bids.
